## KAZAKHSTAN: List of 203 known 2023 administrative prosecutions

*The 203 known administrative prosecutions in 2023 for exercising freedom of religion or belief are listed here. More than one third punished individuals for posting religious materials on social media without state permission. A quarter punished individuals for offering religious literature for sale - in shops or online - without state permission. One individual and one charity were prosecuted for having religious books, although this is not an offence. The Information and Social Development Ministry (of which the Religious Affairs Committee is a part) claimed wrongly that there were only 139 such cases in 2023.*

The regime is known to have brought at least 203 administrative prosecutions in 2023 - an average of 17 per month - to punish individuals and organisations for their exercise of freedom of religion or belief. This is the highest level of prosecution since 2017. Of these, 172 ended with convictions and punishments. Almost all of the punishments included fines of between several days' and several months' average wages.

A third of the 2023 cases ([https://www.forum18.org/archive.php?article\\_id=2900](https://www.forum18.org/archive.php?article_id=2900)) were (as in previous years) to punish individuals for posting religious messages, texts and recordings on their social media accounts without state permission (see full list below).

The next biggest set of cases (as in previous years), nearly a quarter of the 2023 total, punished individuals for offering religious literature for sale without state permission, either in shops or online (see full list below).

Just as in 2022, prosecutions were in 2023 brought for having religious books, although this is not an offence. One charity was acquitted, but an individual was fined (see full list below).

Commercial and private sellers, as well as Muslims, Jehovah's Witnesses and Protestants, were among the individuals targeted in these prosecutions. Also targeted were business and charities. In one case, a religious picture seized from an individual offering it for sale online was ordered destroyed. Unlike in previous years, courts in 2023 are not known to have ordered religious literature to be destroyed (see full list below).

Muslims from the Dungan ethnic minority continue to be apparently disproportionately targeted in comparison to other people groups for teaching the Koran and Islam to local children without state permission ([https://www.forum18.org/archive.php?article\\_id=2900](https://www.forum18.org/archive.php?article_id=2900)).

The 203 known administrative cases in 2023 ([https://www.forum18.org/archive.php?article\\_id=2900](https://www.forum18.org/archive.php?article_id=2900)) show an increase from 2022 in the number of prosecutions. However, the true number of such administrative cases is likely to be higher. The Information and Social Development Ministry (of which the Religious Affairs Committee ([https://www.forum18.org/archive.php?article\\_id=2753](https://www.forum18.org/archive.php?article_id=2753)) is a part) claimed that there had been 139 such cases in 2023 ([https://www.forum18.org/archive.php?article\\_id=2900](https://www.forum18.org/archive.php?article_id=2900)).

The 203 known 2023 administrative prosecutions for exercising freedom of religion and belief ([https://www.forum18.org/archive.php?article\\_id=2900](https://www.forum18.org/archive.php?article_id=2900)) compare with:

Punishments in 2023 ([https://www.forum18.org/archive.php?article\\_id=2900](https://www.forum18.org/archive.php?article_id=2900)) included temporary bans on specified or unspecified activity, verbal reprimands, and fines for among other things posting religious materials online, selling Bibles, Korans, and icons online, as well as teaching children to read the Koran without state permission, trying to import religious books, and saying the word Amen in mosques – and even having religious books, although this is not an offence. One foreign citizen was ordered deported. In one case, a religious picture was ordered destroyed. Unlike in previous years, courts in 2023 are not known to have ordered religious literature to be destroyed (see full list below).

Fines are the most common punishment, with fines for individuals mostly being between three weeks' and two months' average wages. For pensioners and those without formal work, such fines can be a heavy burden. Individuals who are punished for offering religious materials for sale online often tell the courts that they are desperately short of money and are trying to sell any property they no longer need. This does not stop judges from fining them.

In addition to fines, courts often ban individuals from activity for three months. Sometimes the ban is unspecific, leaving individuals unclear about what they can and cannot do. In other cases courts ban specific activities, for example distributing religious materials (which is in any case illegal without state permission). The hardest-hitting bans are on those running shops, as a three-month ban leaves owners and employees with no income from the shop.

Neither the regime's Human Rights Commissioner Artur Lastayev, nor the regime's Religious Affairs Committee ([https://www.forum18.org/archive.php?article\\_id=2753](https://www.forum18.org/archive.php?article_id=2753)), nor police were willing to explain to Forum 18 why individuals and organisations continue to be punished for exercising freedom of religion or belief ([https://www.forum18.org/archive.php?article\\_id=2900](https://www.forum18.org/archive.php?article_id=2900)).

Such cases have continued in 2024. Six individuals are known to have been fined in 2024 for trying to bring religious literature into the country without state permission. On 1 April 2024, a religious affairs official in Almaty drew up a record of an offence against a Protestant, Sergei Orlov, who had spoken at a meeting of church members in a flat on 8 March to mark international women's day. The case has not yet been sent to court (see below).

"To restore social justice"?

The March 2023 court decision in the case of Bakhytkul Kosmambetova in Baikonur outlines the regime's excuses for punishing people for exercising freedom of religion or belief without state permission.

The decision (echoing the wording of 3 other such decisions) noted that "the court took into account her identity, property situation, and in order to restore social justice, to educate her in the spirit of compliance with the requirements of laws and respect for law and order, as well as to prevent her from committing a new offence".

#### Known 2023 cases

There were 203 known administrative cases for exercising freedom of religion and belief in the 2023 calendar year:

- 2 (1 individual and 1 charity) for having religious literature ([https://www.forum18.org/archive.php?article\\_id=2900](https://www.forum18.org/archive.php?article_id=2900)) (2 in 2022, 0 in 2021, 0 in 2020, 0 in 2019, 0 in 2018, 0 in 2017).

- 41 individuals for offering religious literature or other items for sale without state permission ([https://www.forum18.org/archive.php?article\\_id=2900](https://www.forum18.org/archive.php?article_id=2900)) (31 in 2022, 18 in 2021, 26 in 2020, 30 in 2019, 34 in 2018, 58 in 2017).

- 7 individuals for online offering religious literature or other items for sale online without state permission ([https://www.forum18.org/archive.php?article\\_id=2900](https://www.forum18.org/archive.php?article_id=2900)) (9 in 2022, 18 in 2021, 29 in 2020, 24 in 2019, 18 in 2018, 10 in 2017).

- 67 individuals for posting religious materials online without state permission ([https://www.forum18.org/archive.php?article\\_id=2900](https://www.forum18.org/archive.php?article_id=2900)) (54 in 2022, 40 in 2021, 28 in 2020, 33 in 2019, 23 in 2018, 12 in 2017).

- 7 individuals for trying to import religious literature without state permission ([https://www.forum18.org/archive.php?article\\_id=2900](https://www.forum18.org/archive.php?article_id=2900)) (6 in 2022, 0 in 2021, 1 in 2020, 4 in 2019, 0 in 2018, 4 in 2017).

- 24 individuals for sharing faith with others without state permission ([https://www.forum18.org/archive.php?article\\_id=2900](https://www.forum18.org/archive.php?article_id=2900)) (3 in 2022, 3 in 2021, 10 in 2020, 8 in 2019, 17 in 2018, 31 in 2017).
- 13 Muslims for praying in mosques ([https://www.forum18.org/archive.php?article\\_id=2900](https://www.forum18.org/archive.php?article_id=2900)) in ways that the state-controlled Muslim Board has banned, for example by using the word "Amen" ([https://www.forum18.org/archive.php?article\\_id=2753](https://www.forum18.org/archive.php?article_id=2753)) (3 in 2022, 12 in 2021, 9 (one twice) in 2020, 9 in 2019, 21 in 2018, 22 in 2017, the first year such punishments were imposed).
- 12 (10 individuals and 2 charities) for teaching their faith to children without state permission ([https://www.forum18.org/archive.php?article\\_id=2900](https://www.forum18.org/archive.php?article_id=2900)) (8 in 2022, 6 in 2021, 7 in 2020, 4 in 2019, 3 in 2018, 2 in 2017).
- 1 individual for allowing children to be present or conducting religious rites against the wishes of one parent ([https://www.forum18.org/archive.php?article\\_id=2900](https://www.forum18.org/archive.php?article_id=2900)) (0 in 2022, 0 in 2021, 0 in 2020, 1 in 2019, 1 in 2018, 9 in 2017).

Almost all the 203 known 2023 cases were heard in court. A total of 12 fines or warnings are known to have been summarily handed down by police ([https://www.forum18.org/archive.php?article\\_id=2715](https://www.forum18.org/archive.php?article_id=2715)) in 2023 (0 in 2022, 2 in 2021, 3 in 2020, 20 in 2019).

No individuals are known to have been prosecuted in 2023 for trying to build a place of worship without state permission (1 in 2022, 0 in 2021, 0 in 2020, 0 in 2019, 0 in 2018, 0 in 2017).

No religious communities are known to have been prosecuted in 2023 for "inadequate" security or security measures for their places of worship, for example not having enough video cameras (0 in 2022, 0 in 2021, 0 in 2020, 2 in 2019, 2 in 2018, 5 in 2017).

No individuals are known to have been prosecuted in 2023 for failing to pay earlier fines to punish them for exercising the right to freedom of religion or belief without state permission (0 in 2022, 0 in 2021, 0 in 2020, 0 in 2019, 2 in 2018, 2 in 2017).

One foreign citizen is known to have been ordered deported in 2023 (2 in 2022, 0 in 2021, 0 in 2020, 0 in 2019, 1 in 2018, 2 in 2017).

Cases continue in 2024

Administrative cases continue to be brought in 2024 to punish the exercise of freedom of religion or belief.

At least six individuals are known to have been fined already in 2024 ([https://www.forum18.org/archive.php?article\\_id=2900](https://www.forum18.org/archive.php?article_id=2900)) for trying to bring religious literature into the country without state permission.

On 1 April 2024, Almaz Zhanamanov of Almaty City Religious Affairs Department drew up a record of an offence under Administrative Code Article 490, Part 3 against a Protestant, Sergei Orlov. He had spoken in a flat on 8 March to a group of church members who were meeting to mark international women's day. Orlov spoke of women in the Bible. He knew all of those present, except one man who filmed the meeting, Orlov told Forum 18.

On 13 March, a woman reported the meeting to the police, asking for the church to be investigated. The police passed the information to the city's Religious Affairs Department. On 1 April, Orlov was summoned to the Religious Affairs Department. Zhanamanov then drew up the record of an offence. The case has not yet reached Almaty Inter-District Specialised Administrative Court.

Orlov insists there was no reason for officials to bring a case against him and intends to challenge this in court.

Asked why he had drawn up the record of an offence, Zhanamanov refused to explain. "On all questions you should apply officially to the Department," he told Forum 18 on 5 April.

Administrative Code Article 489 ([https://www.forum18.org/archive.php?article\\_id=2753](https://www.forum18.org/archive.php?article_id=2753)), Part 9 punishes "Leadership of an unregistered, halted, or banned religious community or social organisation" with a fine of 100 MFIs.

Administrative Code Article 489 ([https://www.forum18.org/archive.php?article\\_id=2753](https://www.forum18.org/archive.php?article_id=2753)), Part 10 punishes "Participation in an unregistered, halted, or banned religious community or social organisation" with a fine of 50 MFIs.

Administrative Code Article 490 ([https://www.forum18.org/archive.php?article\\_id=2753](https://www.forum18.org/archive.php?article_id=2753)), Part 1, Point 1 punishes "violation of procedures established in law for conducting rites, ceremonies and meetings". Punishment for individuals is a fine of 50 MFIs, and for organisations a fine of 200 MFIs and a three-month ban on activity.

Administrative Code Article 490 ([https://www.forum18.org/archive.php?article\\_id=2753](https://www.forum18.org/archive.php?article_id=2753)), Part 1, Point 3 punishes: "Violating the requirements of the Religion Law for .. import, manufacturing, production, publication and/or distribution of religious literature and other religious materials, and items for religious use". The punishment for individuals is a fine of 50 MFIs.

Administrative Code Article 490 ([https://www.forum18.org/archive.php?article\\_id=2753](https://www.forum18.org/archive.php?article_id=2753)), Part 1, Point 4 punishes: "Violating the requirements of the Religion Law for .. building places of worship (facilities), or changing the usage (altering the functional designation) of buildings (facilities) into ritual buildings (facilities)". The punishment for individuals is a fine of 50 MFIs.

Administrative Code Article 490 ([https://www.forum18.org/archive.php?article\\_id=2753](https://www.forum18.org/archive.php?article_id=2753)), Part 3 punishes: "Carrying out missionary activity without state registration (or re-registration), as well as the use by missionaries of religious literature, information materials with religious content or religious items without a positive assessment from a religious studies expert analysis, and spreading the teachings of a religious group which is not registered in Kazakhstan". The punishment is a fine of 100 MFIs, with deportation if the individual is a foreign citizen.

In 2023, fines were mostly the equivalent of between three weeks' (35 MFIs) and four months' (200 MFIs) average wages for those in formal work.

The regime regards saying the word "Amen" in mosques (used as a prayer by Sunni Hanbali Muslims) ([https://www.forum18.org/archive.php?article\\_id=2753](https://www.forum18.org/archive.php?article_id=2753)) as one instance of this "offence".

The punishment for individuals is a fine of up to 50 MFIs, and for legal entities up to 200 MFIs.

Administrative Code Article 490 ([https://www.forum18.org/archive.php?article\\_id=2753](https://www.forum18.org/archive.php?article_id=2753)), Part 8 punishes repeat violations of the Religion Law within one year, with fines on individuals of up to 200 MFIs.
